



Reseller Agreement

This agreement covers all terms and conditions for participating in the WHMCS Reseller program. In this agreement the term “reseller” refers to the applicant and the term “website” refers to your website of business operations.

SERVICE PROVISION

The WHMCS Software is supplied by WHMCS Limited, and is licensed, not sold, under the terms of the EULA. WHMCS Limited reserves all rights not expressly granted to you and WHMCS Limited retains the ownership of the Software.

WHMCS Limited reserves the right to refuse service to individuals at their discretion.

END USER LICENSE AGREEMENT

The EULA Agreement is included in the WHMCS download package. By installing, copying, or otherwise using WHMCS, your resold customers agree to be bound by the terms of the EULA.

LICENSE PROVISIONING

In order to become a WHMCS reseller, there is a minimum initial purchased required of 5 keys. These 5 keys must remain active at all times. Dropping below 5 active keys will forfeit reseller status and cause all remaining licenses to be returned to regular retail rates.

Additional licenses can be purchased on demand, as required, in minimum blocks of 3 at a time, via the Reseller Portal section of our members area @ www.whmcs.com/members/resellerportal.php

LICENSE DISTRIBUTION

As a WHMCS Reseller, you may “resell” or “give away” WHMCS licenses as a value added product alongside your web hosting services (reseller/dedicated/vps/etc..).

Licenses must never be sold as a standalone product. In addition, all licenses you issue must be used on the hosting services you provide.

DOWNLOADS

Resellers are responsible for providing access to the WHMCS files necessary for resold customers to install and use the software. These files should only ever be accessible to those entitled to them by having a license, and must not be publically accessible.

LICENSE USAGE

WHMCS Limited reserves the right to perform an audit of license keys issued by a reseller at any time, and the reseller may be asked to provide a list of IPs that belong to their network to

facilitate this. Failure to provide evidence that licenses are being used solely within the resellers hosting network may lead to suspension.

BILLING POLICY

Payment is due on the anniversary of keys being issued. If payment is not received within 5 days of this date, licenses will be suspended until payment is received.

All sales are final and non-refundable. Cancellations during an active month of a license do not warrant money back for the unused time.

ADVERTISING INFORMATION

The reseller is solely responsible to ensure that any content, information, features, functions and included items with our product displayed on their website remains current and correct. WHMCS will not be held responsible, liable or at fault if any information provided to your customers is not considered correct.

SUPPORT

All customers who are sold a license for WHMCS from a reseller have the right to contact us directly for support. If however the resellers account is not in good standing then the customer may be denied support until the account issues have been resolved.

BRANDING

Re-branding or removal of WHMCS references from the software itself or any associated files are not permitted.

CANCELLATIONS & AGREEMENT MODIFICATIONS

WHMCS reserves the right to change any portion of the conditions in this agreement, at any time and in its sole discretion. Any modifications made shall be considered accepted by the reseller unless a notice of termination is received within 14 business days of the reseller being notified of the change.

Either party reserves the right to cancel this agreement at any time by written notice of cancellation to the receiving party. Any cancellation by the reseller requires a 3 month notice period and the resold customers email addresses to be provided to WHMCS to allow offering the option to continue with WHMCS directly to avoid interrupting service. Any cancellation forfeits all payments and warrants no refund of unused portions. If at any time during your reseller agreement any item of this agreement is breached, your reseller account may be terminated "immediately" without any right to refund of any moneys paid for licenses.
